Carassa is Member of the PhD Board of the Doctoral School in Human Sciences, Program in Education and Communication Sciences, Università Milano Bicocca.

Within professionally-oriented contexts, Antonella Carassa has exploited her psychological competences by contributing to the foundation of the Swiss National Association of Counseling (ANSCO), linked to the European Association of Counseling (EAC), and of the Society of Cognitive-Relational Counseling. These associations intend to promote the counseling training, consulting and supervision, and to guarantee a code of ethics and means of recognizing professional competence.

Carassa is also offering a service to Canton Ticino by contributing to understand how mothers can be supported in the delicate period close to the child birth and in the following two years of life. The longitudinal research on early mother-child interaction, besides the expected theoretical and empirical results addressed to the scientific community, has offered the opportunity to establish a fruitful and close relationship with health care operators and parental couples. This project is the first extensive study on the Swiss territory aimed at identifying signs of mothers' diseases (post-partum depression or others), mother-child relationship disturbance, and any risk factors for the future development of the child. For this reason the potential users of the project will be the Developmental Health Care services, with the possibility to design a network of services to support parental care, family well-being, and child development. A continuing collaboration on these aspects is active with "Associazione Progetto PANDA", an association in Regione Lombardia (Italy) with a long and important experience in this field. At present, the request to participate to the project has been accepted with a great interest and commitment by both the local population and the Hospital Maternity Service operators in Ticino.
